## AMERICAN STUDIES

### WRENCHED



Directed by ML Lincoln

Captures the generations of eco-activists, from the 1960s to the present day, inspired by Edward Abbey's passionate defense of wilderness in *The Monkey Wrench Gang*.

From Upton Sinclair's *The Jungle* to Rachel Carson's *Silent Spring*, American literature has a history of being in the vanguard when it comes to activism about controversial issues. The books of Edward Abbey carry on that tradition, with memoirs like *Desert Solitaire* and the classic comic novel, *The Monkey Wrench Gang*, taking on the degradation of the American Southwest.

*WRENCHED* reveals how Edward Abbey's anarchistic spirit and riotous novels influenced and helped guide the nascent environmental movement of the 1970s and '80s. Through interviews, archival footage and re-enactments, the film captures the outrage of Abbey's friends who were the original eco-warriors. In defense of wilderness, these early activists pioneered "monkeywrenching" - a radical blueprint for "wrenching the system." Exemplified by *EarthFirst!* in the early '80s, direct action and civil disobedience grew in popularity.

*WRENCHED* captures a new generation of monkeywrenchers who use Abbey's books as a source of inspiration. They are personified by Tim DeChristopher, who single-handedly stopped the sale of 100,000+ acres of public trust lands in southeastern Utah. The fight continues to sustain the last bastion of the American frontier - the spirit of the West. And *WRENCHED*, following in Abbey's footsteps, asks the question: How far are we willing to go in defense of wilderness?

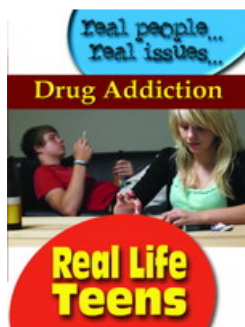

Does the idea of patriarchy still resonate today, given our increasingly gender-diverse culture and feminist achievements? Gilligan gives a definitive yes in this interview, where the longtime professor and author gives her thoughts on modern feminism, gender within the family, and the positive potential impact of women's empowerment on child development.

Over the hour-long interview, Gilligan draws compelling connections to suggest a relationship between patriarchy,

parenting, and pleasure. She examines ways that the family unit, particularly mother-daughter and mother-son relationships, exemplifies and maintains patriarchy; the ways that self-denial women are conditioned to adopt leads to a denial of their own pleasure, as well as their power both as women and as strong maternal figures. For women, she continues, pleasure is a psychosocial dilemma that can be even harder to acknowledge than pain, both because women aren't socially allowed to embrace their desire and because feeling into desire triggers grief and shame.

Feminist psychotherapy, she maintains, can compel women to face up to their disowned selves, own their authentic voices, and be more present for the sake of their children" especially their daughters, who long for empowered role models. Gilligan offers a rich overview of the nuances of feminism today" be sure to add this one to your library.

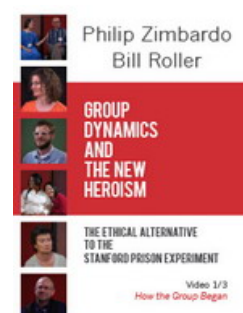

This activity has been developed for health care employers and employees to brief them about laws and rules governing background screening requirements under Chapter 435, Florida Statutes and Rule 59A-35.090, Florida Administrative Code. All personnel that interact with members of vulnerable populations and certain other employees are required to comply with background screening laws and rules. Effective July 1, 2014, amendments added additional disqualifying crimes, allows certain previously approved and qualified personnel to continue working while applying for an exemption and eliminated the 3-year exemption waiting period after payment of fines for certain felony convictions.

### PHIL ZIMBARDO ON THE STANFORD PRISON EXPERIMENT, EVIL AND HEROISM

In 1971, Dr. Philip Zimbardo led the notorious Stanford Prison Experiment in order to answer the question, "What happens when you put good people in an evil place?" In this interview with Victor Yalom, Zimbardo speaks in-depth on the study, its lessons, and its relationship to Abu Ghraib decades later.

Over the course of the interview, Zimbardo describes the arc of the controversial study, with lively storytelling that fascinates even as it confounds. He goes on to outline the rise and fall of the experiment, the participants' parents ultimate compliance during its run, and his own internalization of the "prison super" role (only made apparent to him upon his then-girlfriend's threat to end their relationship). He then extrapolates his findings to the more recent Abu Ghraib trials, where he was involved in examining the systemic torture proliferating among the unsupervised guards.

Zimbardo's discoveries remain relevant in the age of widespread police brutality charges, an increasingly divided government, and international political strife. You'll find many compelling ideas to consider from his work, so be sure to take a look at this ever-timely interview.

Emotion-focused therapy for trauma (EFTT) is an evidence-based, short-term therapy for clients dealing with issues stemming from child abuse trauma. Unique challenges are associated with this form of trauma, including emotion regulation difficulties and narratives devoid of affect or personal meaning.

Narrative processes in EFTT focus not only on the content but the quality of client narratives " that is, how a client recounts his or her experiences. Therapists trained in this approach pay attention to the presence and type of affective experience, level of emotional arousal and engagement with trauma material, and narrative coherence. Narrative process interventions access healthy sub-dominant aspects of the client's experience and use these to promote construction of more detailed and meaningful narratives.

In this video, Drs. Lynne Angus and Sandra C. Paivio demonstrate and discuss key therapeutic interventions that

encourage and direct a client through narrative and emotion-focused processes to gain acceptance and clarity on unresolved issues.
